BIODIVERSITY at ... Pharmos Natur – where the diversity of life becomes visible

The Pharmos Natur medicinal plant cosmetics business proves that you can make big differences in small ways when it comes to biodiversity. Biodiversity can only be sustainably protected if sustainability is implemented in many areas of life. The approach which describes the complexity of biodiversity is therefore very diverse. Maintaining diversity in all areas of life and fostering it for the benefit of people and nature means living and working in a sustainable and holistic way. In its work, Pharmos Natur focuses on natural resources and on the human being. Knowledge from ancient cultures is integrated into new scientific findings. This is why worldwide cooperation projects are given a sustainable basis at Pharmos Natur right from the start.

"Black sesame, terminalia chebula and phyllanthus emblica fruits" cooperation projects

In cooperation with local businesses such as farmers and craftsmen, Pharmos Natur launched the "black sesame, terminalia chebula and phyllanthus emblica fruits" cooperation projects in Nepal back in 1999. Initially, ten small farming families were involved. The aim was to build up a business for the ecological production of local plants according to EU directives, with the involvement of the local population.

Today, there are about 250 cooperation contracts with small farmers in the fields of cultivation and harvests. The first step taken was to counteract malnutrition among the farmers involved and to provide the appropriate infrastructure for the implementation of the project. By creating a "subsistence garden", the farmers were given the opportunity to have a balanced and healthy diet.

In order to integrate the project in the social environment, Pharmos Natur made extensive investments. Not only were infrastructure and accommodation built, an electricity and water supply set up and basic medical care provided for the village population, comprehensive training sessions were also carried out to educate people about ecological farming, hygienic and technological requirements and quality control and assurance issues.

The project contributes to enabling small farmers to benefit from Nepal's natural resources in a sustainable manner and to create stable incomes in the long-term. Qualified employees on-site ensure that the measures are well coordinated and implemented. The level of education among the farmers and their families in both general and specific areas is increasing.

Cooperation with Padre Bertram – "aloe vera" project in Ecuador

For more than 20 years, Padre Bertram Wick has been supporting the parish of Colonche in Ecuador. There is a special connection between his "aloe vera" project and the company founder Margot Esser of

Pharmos Natur and Padre Bertram work and think in a holistic way in every respect, not only in their heads, but also in their hearts. The plants are harvested manually and with a great deal of care. From pure strip cultivation through harvesting and processing and on to marketing, they work together to realise the claim of sustainability. They also contribute to creating an ecological, economic and social balance.

Only four months to go: The 12th Conference of the Parties (CoP) to the Convention on Biological Diversity (CBD) is approaching fast and will take place during 6-17 October in Pyeongchang, Republic of Korea. The CBD Secretariat and and CBD Global Partnership for Business and Biodiversity are planning a Business Forum "Mainstreaming Biodiversity: Innovative Opportunities for Business" between 12th and 14th of October. The 3 day series of business-related activities will comprise business engagement events, including a High Level Segment, a business and biodiversity workshop, a meeting of the Global Partnership, and several media/launch events.

"No net loss" - Internet Consultation of the European Commission



In fulfilling the CBD Strategic Plan 2011 till 2020, the EU Biodiversity Strategy to 2020 aims to halt biodiversity loss and to conserve ecosystem services. The strategy contains 6 operational targets and 20 associated actions. Action 7 is to ensure no net loss of biodiversity and ecosystem services. Under action 7, the Commission is foreseen to propose, by 2015, an initiative on No Net Loss.
